THE CUSTOMER HEREBY UNDERSTANDS THAT IF ANY AMOUNT DUE BECOMES DELINQUENT, SERVICE MAY BE TERMINATED AND/OR DELINQUENT AMOUNTS MAY BE ASSESSED AGAINST THE PROPERTY DESCRIBED HEREINABOVE AND/OR THE CITY MAY UTILIZE ANY OTHER LEGAL REMEDY PROVIDED BY LAW TO ABATE OR TO CORRECT ANY VIOLATION OF SAID RULES AND REGULATIONS. BY PROVIDING US WITH YOUR WIRELESS/CELL PHONE NUMBER, YOU ARE HEREBY GRANTING US, AND OUR AGENTS OR INDEPENDENT CONTRACTORS, YOUR CONSENT TO RECEIVE CALLS ON YOUR WIRELESS/CELL PHONE NUMBER FOR BILLING AND DEBT COLLECTION PURPOSES. IT IS HEREBY AGREED THAT THE CITY'S AUTHORIZED AGENTS SHALL HAVE ACCESS AT ALL REASONABLE TIMES TO THE PREMISES WHERE SERVICE IS BEING FURNISHED FOR THE PURPOSE OF READING METERS, AND FOR ANY OTHER RELATED PURPOSE INCLUDING, BUT NOT LIMITED TO, INSPECTING, OBSERVING, MEASURING, SAMPLING, TESTING, EXAMINING, REMOVING/REPAIRING EQUIPMENT OF THE UTILITIES SYSTEM, AND/OR DISCONNECTING THE SERVICE IF THE CUSTOMER IS DELINQUENT IN THE PAYMENT OF ANY AND ALL BILLS RENDERED, OR TO PREVENT FRAUD, OR ABUSE. THE CUSTOMER SHALL BE RESPONSIBLE FOR ANY LOSS OR DAMAGE TO THE CITY'S PROPERTY WHILE THE SAME IS ON THE PREMISES OR IN THE CARE & CUSTODY OF THE CUSTOMER/PROPERTY OWNER. THE CITY SHALL NOT BE LIABLE FOR FAILURE TO SUPPLY SERVICE, OR FOR INTERRUPTION OR IRREGULARITY OF SERVICE, AND SHALL MAKE EVERY EFFORT TO RESTORE ADEQUATE SERVICE AT THE EARLIEST PRACTICAL MOMENT.
